### RECOMMENDATIONS OF THE SUB COMMITTEE:

After verification of all the original records of your college regarding continuation of affiliation for the academic year 2018-19. The following conditions shall compulsory be fulfilled for 02 years B.Ed course as per the NCTE norms and standards and Gazette Notification 2014.

1. A shifting permission has to be taken both from the University and the NCTE
2. An independent building along with all the required facilities has to be maintained as per the NCTE norms.
3. 1+12 teaching staff along with required strength of non-teaching staff for Unit-I to be appointed and approved from the University as per the NCTE norms.
4. NAAC condition has to be fulfilled within 05 years of B.Ed course recognition from the NCTE as per the norms.
5. All other required conditions of NCTE mentioned in your recognition order copy and as per the norms.
6. This report shall also be sent to the NCTE, New Delhi and the Central Admission Cell (CAC), Bangalore every year for initiating further necessary action.

However, before confirming admission and issuing eligibility to all the 2018-19 batch students, the university must ensure availability and working of all the 1+7 teaching staff for Unit-I and 1+15 teaching staff for Unit-II for teaching/Assessing/A warding marks as per the norms and regulations of the course.

**Local Enquiry Committee Conditions:**

1. Mandatory disclosures along with staff appraisal has to be uploaded in the college website immediately as per the norms.
2. The demarcated land and new building has to be made in the NAME of ITS TEI (Teacher Education Institution) and the B.Ed Course has to be shifted to the new building and shifting permission has to be obtained from the NCTE as well as from the university as per the norms.
3. The college has to get NAAC Accredited within 05 years of its recognition as per the NCTE Norms.
4. The college has to appoint the renaming 1+1 lectures in the respective subjects and other required non-teaching staff and take approval from the University.
5. The infrastructural, instructional and other amenities are to be provided as per the NCTE norms. However the following conditions need to be fulfilled at the earliest.
  - a) Library collections has to be added with books of 200 titles annually, 10 journals and adequate reference books as per the new course curriculum.
  - b) All laboratories are to be strengthened by purchasing new equipments.
  - c) Scale of Salary has to be introduced and PF and ESI has to be maintained.
  - d) Salary has to be paid through cheque on individual account of the staff.
  - e) The FDRs of Rs. 5 Lakhs and Rs. 3 Lakhs to be made joint A/C in the name of NCTE and the management.
