

### Rules governing Academic Collaboration between two institutions

- Each institution will nominate one of its members as its representative in-charge of the cooperative program. Individual programs of work under this Memorandum will be jointly planned and conducted by the nominees of both parties.
- 2. Progress of the work of any individual program will be reviewed and approved by designated authorities of both parties.
- The final approval of any project will depend on the availability of guaranteed support.
